

Meeting of the Selection Board for EFSA's Discussion Group on Environmental Risk Assessment (Stakeholder DG on ERA)

1. Background

Environmental risk assessment (ERA) of plant protection products (PPPs) is required by Regulation (EC) No 1107/2009, which regulates the placing on the market of these products in the European Union. In line with EFSA 2027 Strategic objectives on ensuring preparedness for future risk analysis needs, more up-to-date scientific guidance and methodological approaches need to be developed. For regulatory environmental risk assessment (ERA), opportunities identified so far include the integration of several aspects related to the landscape (e.g., landscape structure and ecology) and combining prospective and retrospective assessments. To develop such integrated assessments, EFSA has established a multiannual plan for 2024-2028 to advance the ERA of PPPs¹². The activities under this multiannual plan aim, primarily, to consolidate risk assessment methodologies for PPPs, and to integrate new tools and scientific knowledge.

Furthermore, in consideration of a prioritistation exercise identifying a priority list for the revision of guidance documents (GDs)³, the European Commission announced to mandate EFSA for the revision of Guidance Document (GD) on Terrestrial Ecotoxicology (EC, 2002)⁴. This GD includes non-target arthropods (NTAs), non-target terrestrial plants (NTTPs), in-soil organisms. In addition, the European Commission mentioned to request EFSA to develop an approach for including indirect effects on biodiversity via trophic interactions⁵.

Overall, considering both the complexity of the subject and the stakeholder and public interest, EFSA has decided to establish a Stakeholder Discussion Group⁶ on ERA. The group will be informed and, where needed, consulted at various stages of the revision of the above GD, and on any relevant development of the EFSA multiannual plan and activities in the area of ERA.

4. Selection criteria

The selection followed the principles established in EFSA's Stakeholder Engagement Approach and the Decision of the Management Board of EFSA on the criteria for establishing a list of stakeholders and the establishment of the Stakeholder Forum and Stakeholder Bureau. In particular, EFSA considered the principles included in the Framework for Interaction between the European Food Safety Authority and the Stakeholder Discussion Group on Environmental Risk Assessment (Stakeholder DG on ERA) also listed below:

- Knowledge and expertise of the nominated stakeholder expert, considering the need for the Stakeholder Discussion Group to cover a range of technical and scientific areas in the environmental risk assessment, particularly on terrestrial ecotoxicology, including agronomy and landscape ecology;
- Interest in the field and expected benefits from the participation of the organisation as expressed in its application;
- Role and remit of the organisation at the EU level;
- Achieving a balanced representation of stakeholder interests and categories.

Upon the analysis of the 15 applications from the 10 organisations, 12 experts fulfill the above criteria, and they are listed in section 5.
